Regarding approval of Sitting fees, TA /DA and other facilities to the Chairman and BOD Members of the Una Distt. Cooperative Development Federation Ltd; Una, HP

Whereas, the request of the Una Distt. Cooperative Development Federation Ltd; Una, HP has been received through Additional Registrar, Cooperative Societies along with the resolution passed by the Managing Committee of the said Federation in its meeting held on 28.6.2022, requesting to accord approval to enhance the Sitting Allowances, Daily Allowances and other facilities to the Chairman and BOD members of the said Federation.

Whereas, the matter has been examined in this office. After due consideration of the matter and keeping in view of hike in the rate of inflation and other factors, it is deemed fit to revise the existing rate of sitting fees and daily allowances etc. in respect of Chairman and members of the Board of Directors of the said federation on the analogy of the Bilaspur and the Solan District Cooperative Development Federations.

Now, therefore, in pursuance of the provision of rule 152 of the H.P Cooperative Societies Rules 1971, following directive is issued to revise/enhance the rates of Sitting Allowances and Daily Allowances etc. in respect of Chairman and members of the Managing Committee of the above mentioned District Cooperative Development federation subject to the condition of the available financial resources of this Federation and till the financial health of the institution remained good.

Apart from this, there shall be a ceiling of maximum 10 days for drawing sitting fees in respect of Chairman of above mentioned federation for performing and disposing the works at the Headquarter of the Federation.



However these rates will be apply only if the Una District Cooperative Federation is functional and remains in profit.
