NOTIFICATION

Whereas, the draft Himachal Pradesh Co-operative Societies Rules, 1971, were published in the Rajpatra (e-Gazette) Himachal Pradesh on 29.12.2023 vide this department notification of even number dated 26.12.2023 for inviting objection(s) and suggestion(s) from the persons likely to be affected thereby, as required under section 109 of the Himachal Pradesh Co-operative Societies Act, 1968 (Act No 3 of 1969);

And whereas, objection(s)/suggestion(s) have been received from the persons likely to be affected thereby within the specified period, which have been considered by the Government;

Now, therefore, in exercise of the powers conferred by the section 109 of the Himachal Pradesh Co-operative Societies Act, 1968 (Act No. 3 of 1969), the Governor of Himachal Pradesh is pleased to make the following rules, namely:-

DRAFT RULES

Short title and commencement

- 1. (1) These rules may be called the Himachal Pradesh Co-operative Societies (Amendment) Rules, 2024.
 - (2) It shall come into force from the date of their publication in the Rajpartra (e-Gazette), Himachal Pradesh.

Amendment of rule 56.

- 2. In the Himachal Pradesh Co-operative Societies Rules, 1971 (hereinafter referred to as the 'said rules'), for subrule (3) of rule 56, the following shall be substituted, namely:-
 - "(3) No Co-operative Society shall employ a salaried officer or servant with total monthly emouments exceeding rupees 'fifteen thousand' without the previous permission of the Registrar:

Provided that if operating expenses of a cooperative society, excluding the amount of depreciation exceeds its income in a financial year, such society shall not employ any salaried officer or servant in the next succeeding financial year: Provided further that no co-operative society shall employ salaried officer or servant exceeding the cadre strength, if any, fixed by the Registrar by a special or general order, and shall not fill more than ten vacancies in a financial year under this sub-rule without prior permission of the Registrar."

Amendment of rule 69.

3. In rule 69 of the said rules,-

- (a) for sub-rule(1), the following shall be substituted, namely:-
 - " (1) Every society shall contribute to the 'Co-operative Education Fund', as provided in section 54 of the Act. Every Cooperative Society shall contribute to this fund at the rate of rupees hundred or one percent of net profit of the year whichever is more but subject to a maximum of Rs. Five lacs to be administered by the Himachal Pradesh Co-operative Development Federation (hereinafter mentioned as State Co-operative Development Federation) and in its absence by any other agency duly authorized by the Government in this behalf. Every Cooperative society shall also contribute at the rate of Rs Two Hundred or 2% of its profit in a year whichever is more but subject to Rs. Ten Lac in Cooperative Education Fund to be administered at its own level. This fund shall be utilized by the Cooperative Society itself for cooperative education trainings in training institutes of Cooperation Department of State of Himachal Pradesh/Cooperative Banks/ Cooperative training Institutes of Government of India or through training/ exposure visit by any NGO registered in Himachal Pradesh for promotion/training of Cooperatives.";
- (b) for sub-rule (3), the following shall be substituted, namely:-
 - "(3) No part of the Education Fund so administered by the State Cooperative Development Federation or in its absence by any other agency duly authorized by Government in this behalf shall be utilised till the permission of the Registrar is obtained, or regulations approved by him.

The rule provides for the constitution of a Cooperative Education Fund' which shall be administered by the Himachal Pradesh State

Cooperative Development Federation or by any other agency in the absence of the former as well as by Cooperative Societies at their own level. The contribution to the fund shall be made by every registered society at the rate of Rs. 300/- or 3% of the net profits derived from the working in a given year subject to a maximum of Rs. 15 lakhs to be distributed between these institutions as per rule 69(1). The rule read with Section No. 54 of the Act, imposes a statutory obligation on every society for making contribution to this Fund. Out of 3% Cooperative education fund 1% shall be administered by Himachal Pradesh Co-operative Development Federation (hereinafter mentioned as State Co-operative Development Federation) and 2% by cooperative societies at their own level.

Any society desirous of contributing more than the maximum of 3% of profits may do so with the prior permission of the Registrar but this shall not in any way exceed 5% of the net profits of the year.".

Amendment of rule 83A.

4. In rule 83A of the said rules, in sub-rule (1), for clause (b), the following shall be substituted, namely:-

"a firm of more than one Chartered Accountants within the meaning of the Chartered Accountants Act, 1949.".

अतः हिमाचल प्रदेश के राज्यपाल, हिमाचल प्रदेश सहकारी सोसाइटीज अधिनियम, 1968 (1969 का अधिनियम संख्यांक 3) की धारा 109 द्वारा प्रदत्त शक्तियों का प्रयोग करते हुए, निम्नलिखित नियम बनाते हैं; अर्थात् :—

प्रारुप नियम

संक्षिप्त नाम और प्रारंम।

- 1. (1) इन नियमों का संक्षिप्त नाम हिमाचल प्रदेश कॉपरेटिव सोसाइटीज (अमैण्डमेन्ट) रूल्ज, 2024 हैं।
 - (2) ये नियम राजपत्र (ई-गजट), हिमाचल प्रदेश में इनके प्रकाशन की तारीख से प्रवृत्त होंगे।

रूल 56 का संशोधन।

- 2. हिमाचल प्रदेश कॉपरेटिव सोसाइटीज रूल्ज, 1971 (जिन्हें इसमें इसके पश्चात 'उक्त नियम' कहा गया है) के रूल 56 के सब—रूल्ज (3) के स्थान पर निम्नलिखित रखा जाएगा, अर्थात:—
 - "(3) No Co-operative Society shall employ a salaried officer or servant with total monthly emoluments exceeding rupees 'fifteen thousand' without the previous permission of the Registrar:

Provided that if operating expenses of a cooperative society, excluding the amount of depreciation exceeds its income in a financial year, such society shall not employ any salaried officer or servant in the next succeeding financial year:

Provided further that no co-operative society shall employ salaried officer or servant exceeding the

cadre strength, if any, fixed by the Registrar by a special or general order, and shall not fill more than ten vacancies in a financial year under this sub-rule without prior permission of the Registrar."

रूल 69 का संशोधन।

- 3. उक्त नियमों के रूल 69 में, -
 - (क) सब रूल (1), के स्थान पर निम्नलिखित रखा जाएगा, अर्थात:—
 - " (1) Every society shall contribute to the 'Co-operative Education Fund', as provided in section 54 of the Act. Every Cooperative Society shall contribute to this fund at the rate of rupees hundred or one percent of net profit of the year whichever is more but subject to a maximum of Rs. five lacs to be administered by the Himachal Pradesh Co-operative Development Federation (hereinafter mentioned as State Co-operative Development Federation) and in its absence by any other agency duly authorized by the Government in this behalf. Every Cooperative society shall also contribute at the rate of Rs Two Hundred or 2% of its profit in a year whichever is more but subject to Rs. Ten Lac in Cooperative Education Fund to be administered at its own level. This fund shall be utilized by the Cooperative Society itself for cooperative education trainings in training institutes of Cooperation Department of State of Himachal Pradesh/Cooperative Banks/ Cooperative training Institutes of Government of India or through training/ exposure visit by any NGO registered in Himachal Pradesh for promotion/training Cooperatives".
- (ख) सब रूल (3), के स्थान पर नि्म्नलिखित रखा जाएगा, अर्थात:—
 - "(3) No part of the Education Fund so administered by the State Cooperative Development Federation or in its absence by any other agency duly authorized by Government in this behalf shall be utilised till the permission of the Registrar is obtained, or regulations approved by him.

The rule provides for the constitution of a Cooperative Education Fund' which shall be administered by the Himachal Pradesh State Cooperative Development

Federation or by any other agency in the absence of the former as well as by Cooperative Societies at their own level. The contribution to the fund shall be made by every registered society at the rate of Rs. 300/- or 3% of the net profits derived from the working in a given year subject to a maximum of Rs. 15 lakhs to be distributed between these institutions as per rule 69(1). The rule read with Section No. 54 of the Act, imposes a statutory obligation on every society for making contribution to this Fund. Out of 3% Cooperative education fund 1% shall be administered by Himachal Pradesh Co-operative Development Federation mentioned as State Co-operative Chereinafter Development Federation) and 2% by cooperative societies at their own level.

Any society desirous of contributing more than the maximum of 3% of profits may do so with the prior permission of the Registrar but this shall not in any way exceed 5% of the net profits of the year."
