Subject:-

Regarding enhancement of Mileage Charges by own/ private vehicle within state to the non official members of the Bilaspur District Cooperative Marketing & Consumer Federation ltd. Bilaspur (H.P.)

Whereas, the request of the Bilaspur Distt. Cooperative Marketing & Consumer Federation Ltd. Bilaspur has been received through the Deputy Registrar (Central Division) Cooperative Societies Mandi vide letter dated 06<sup>th</sup> May, 2022 along with resolution No. 15 dated 21.03.2022 passed by the Board of Directors of the said federation wherein it has been requested to enhance mileage charges from Rs. 5/- Per KM to Rs. 10/- Per KM by own/ private vehicle within state in respect of non official members of Board of the Directors of the said Federation.

Whereas, the matter has been examined in this office and it has been submitted that non official members of the Board of Directors are presently claiming Rs. 5/- Per KM Mileage Charges by own/ private vehicle within state as per our Directive dated 10-02-2012. After due consideration of the matter and keeping in view of hike in the rate of inflation and other factors, it is deemed fit to revise the existing rate of Mileage Charges by own/ private vehicle within state etc. in respect of non official members of the Managing Committees of the said Federation.

Now, therefore, in pursuance of the provision of rule 152 of the H.P Cooperative Societies Rules 1971, following directive is issued to revise/ enhance the rates of **Mileage Charges by own/ private vehicle within state** in respect of non-official members of the Managing Committee of the above mentioned Federation subject to the condition of the available financial resources of this Federation and till the financial health of this federation remained good as mentioned below:-
